submission pertained to an outline permission submitted for over 3,000 homes and a significant offer of commercial floorspace and open space on a riverside location.

Shottendane Road, Margate – Since the grant of outline planning permission, Dan has been involved in preparing and submitting Reserved Matters Applications, non-material amendment applications for this large-scale, residential development. This has involved being agile in the face of client requests and instructions and preparing amendments and RMAs in a timely manner to ensure the long-term success of the scheme. Following the granting of planning permission, Dan has overseen the discharge of the pre-commencement conditions as the construction phase begins.

Basildon Health Centre – Dan was involved in the conversion of a vacant Debenhams department store in a town centre shopping centre into a state of the art healthcare facility that would support both private healthcare and assist with the local NHS shortfall. Dan oversaw the preparation of the planning application and management of a multi-disciplinary technical and design team and is now overseeing the discharge of conditions following the planning approval.
